## TERMS AND CONDITIONS

1. Sales tax regulations require that sales tax is collected in the states of Wisconsin and Illinois. For purchases shipped to these states, state, county and other local sales tax must be collected on the full purchase amount, including shipping.
2. For payments received in the form of a check, whether a personal or business, please allow seven business days to clear financial institutions. Your products will not ship until your check has cleared and the funds have been received.
3. IP Associates requires that the purchase of Feature Pack licenses equal the number of Time Matters User Licenses held by your firm. Further, IP Associates requires the purchase of additional Feature Pack licenses any time additional Time Matters User Licenses are purchased.
4. An IP Associates Consultant or a Time Matters Certified Independent Consultant (CIC) must install your Feature Package. If your feature package is installed by someone other than an IP Associates Consultant or a Time Matters CIC, your 60 day Satisfaction Guarantee, issued with this package, no longer applies. Installation will likely occur within two weeks of your receipt of the feature package, depending on your availability and the availability of an IP Associates Consultant.

### 60 Day Satisfaction Guarantee

If you are not satisfied with an IP Associates feature package, IP Associates will refund the full purchase price of your Feature Package, less shipping and handling, within 60 days of the date of purchase. In order to process your refund, we ask that you please call (262) 432-1737 for a Return Merchandise Authorization code. The Feature Package must be returned to IP Associates by a delivery system that proves proof of delivery, is prepaid, and will provide delivery in good condition. Your return must contain all CDs and manuals and clearly indicate the Return Merchandise Authorization code. Within 30 days of IP Associates’ receipt of the returned merchandise, a refund will be issued. Any services (training, consulting, customizations, etc.) purchased in addition to your Feature Package are non-refundable.

### Technical Support
